## End-User License Agreement ("Agreement")

Last updated: 29.08.2019

- 3/ This Agreement will terminate immediately, without prior notice from BeardedBrothers.Games, in the event that You fail to comply with any provision of this Agreement. You may also terminate this Agreement by deleting the Game and all copies thereof from Your mobile device or from Your computer.
- 4/ Upon termination of this Agreement, You shall cease all use of the Game and delete all copies of the Game from Your mobile device or from Your computer.
